Course Description:

This course examines approaches to the study of public policy rather than the content of public policy. We examine public policy as an intellectual exercise, to study why and how policy is developed, applied, evaluated, and generally conducted as it is and how policies develop over time. The intent of this approach is to prepare doctoral students to understand the different perspectives of the policy process and to be able to apply them in their own research. Among the topics to be considered in this course are approaches to the study of the policy process, the stage framework of public policy, values and democracy, policy ethics, and others.

Student Learning Outcomes:

Upon completion of the course, students should:

- Have a good grasp of alternative approaches to the examination of public policy and of their respective strengths and limitations
- Develop an awareness of the role of interests, ideas, knowledge, ambiguity, and uncertainty in studying public policy
- Analyze the problems and limits in each stage of the process
- Synthesize perspectives in specific areas of public policy development

Format:

The course is a mixture of lecture and discussion of assigned readings and topics. An important feature of the course is a research report on applying an approach to a particular public policy topic selected by the student in consultation with the instructor. This project includes an in-class literature review, research design, hypothesis specification, and methods of analysis presentation.



Evaluation:

Grading is based on an assignment and participation. Late assignments are not allowed to be turned in.

The assignment is a written application of one theoretical approach. Students are required to explain the main concepts, assumptions, and hypotheses developed by that approach and then apply to an issue or policy of their choice. The length is 6 single-spaced pages with a bibliography of at least 8 sources. APA style is acceptable.
